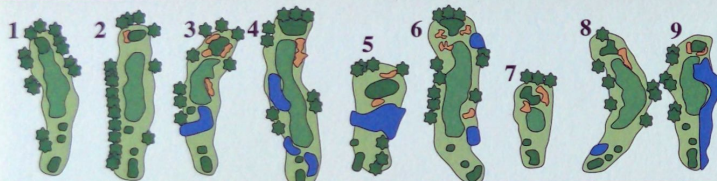

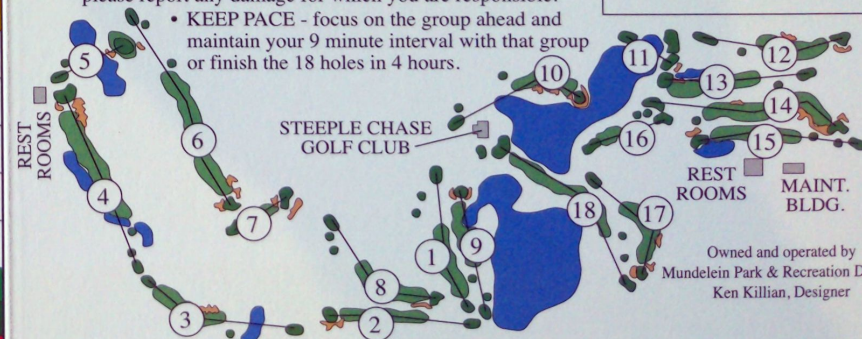
USGA RULES GOVERN ALL PLAY

Out of Bounds defined by white stakes and or perimeter fences.
All new trees are immovable obstructions - Rule 24-2b.
Water hazards on Hole #3, #5, and #11 defined by yellow stakes.
 Hole #3 - drop area - forward tee (beyond wetland).
Lateral hazards - red stakes - all other lakes and wetlands.
Obstructions - the metal bulkheads along the lake on Holes #10, #11 & #18 are immovable obstructions for any ball not in the water hazard.

ALL WETLANDS ARE INCLUDED IN THE USGA RULES REGARDING ENVIRONMENTAL SENSITIVE AREAS. THIS RULE APPLIES TO HOLES #3, 5, 6, 9, 13, 15. PENALTY FOR ENTERING WETLAND - 2 STROKES.

- Proper golf attire please - shirts required.
- Please keep carts on path near greens and tees.
- Please repair ball marks, rake traps, replace divots.
- Respect private property, stay on golf course, and please report any damage for which you are responsible.
- **KEEP PACE** - focus on the group ahead and maintain your 9 minute interval with that group or finish the 18 holes in 4 hours.
